

Razer Pay™ #RazerForLife Campaign
(#RazerForLife Terms & Conditions)

The Razer Pay™ #RazerForLife Campaign (“the Campaign”) is organized by MOL AccessPortal Sdn. Bhd., a subsidiary of Razer Inc. (“Razer Pay”). By taking part in this Campaign, you acknowledge that you (“you”/“your”) have read, understood and agreed to be legally bound by these terms and conditions (“the Campaign Terms”) and decisions of the Razer Pay without limitation or qualification.

You also agree to be bound by the Razer Pay Malaysia Terms of Service on <https://www.razer.com/legal/razer-pay-my-terms-conditions> and/or the Razer Pay™ mobile app which are incorporated by reference into these Campaign Terms. For the avoidance of doubt, capitalised terms used and not defined herein have the same meaning as given to such terms in the Terms of Service. In the event of a conflict between the provisions the Campaign Terms and the Terms of Service, the provisions of these Campaign Terms shall prevail in so far as it applies to the Campaign.

These Campaign Terms are governed by and construed under the laws of Malaysia.

1. Definitions

“Business Day”	means a day (excluding Saturdays, Sundays and public holidays) on which government departments and banks are open for business in Malaysia.
“Campaign”	means the campaign organized by MOL AccessPortal Sdn. Bhd.as described under section 3 of these Campaign Terms & Conditions.
“Coupon”	means the Razer Pay in application coupon as described under section 3 of these Campaign Terms & Conditions which can be redeemed at any Participating Merchant.
“Excluded Participants”	means Razer Pay Users whose Razer Pay accounts have been terminated, suspended, cancelled or dormant within the Campaign Period 1 and 2.
“Campaign Period 1” or “Campaign Period 2”	has the meaning given to it under Clause 2(a) of these Campaign Terms & Conditions.
“Participating Merchants”	means all merchants accepting Razer Pay as a method of payment (including Razer Pay™ in-app purchases).
“Razer Pay Transaction”	means a one-time, minimum RM10 purchase(s) of items in a single transaction at Participating Merchants made by a Razer Pay User through the Razer Pay™ mobile application, during the Campaign Period 2. This excludes transactions in respect of tobacco or transactions in respect of which there are refunds (or refunds initiated) to the Razer Pay User for any reason or transactions which Razer Pay decides, at its sole discretion, are split payments made by the Razer Pay User in respect of the same transaction in order to submit more entries for the Campaign.
“Razer Pay Users”	means: (a) a user who has installed the Razer Pay™ mobile application; (b) has a validly registered Razer Pay™ account with Razer Pay in Malaysia; and (c) is not an Excluded Participant.
“Unverified Razer Pay User”	means a Razer Pay user having validly registered Razer Pay™ account with Razer in Malaysia but is not a Verified Razer Pay User
“Verified Razer Pay User”	means a Razer Pay user having validly registered Razer Pay™ account with Razer in Malaysia and has successfully completed the verification process which includes without the limitation, submission of the below: (a) submit Date of Birth, Residential Address, and Mailing Address according to MyKad/Passport; (b) upload a clear photo of MyKad/Passport; and receive a Razer Pay in-app notification upon successful verification.

2. Campaign Period & Eligibility:

- a. The Campaign shall run from **1 July 2020 to 30 November 2020** (12am to 11.59pm) (both dates inclusive) (“**Campaign Period 1**”) and **1 July 2020 to 31 December 2020** (12am to 11.59pm) (both dates inclusive) (“**Campaign Period 2**”).
- b. You must be a Razer Pay User(s) with a verified Razer Pay account to participate in the Campaign.

3. How to participate in the Campaign:

- a. There are two ways to participate in the Campaign and get a free mask (“Mask”) (via an in-app redemption coupon (“Coupon”)):

- (i) Razer Pay User(s) who during the Campaign Period 1, verify their account (aged 18 years and above) will be eligible to claim one (1) Coupon per month, for each completed month from verification, up until the end of the Campaign Period, subject to a maximum of 5 Coupons per applicable Razer Pay User.

For example, if a Razer Pay User becomes verified in November 2020, he/she will be eligible to claim one (1) Coupon for the month of November 2020 since Campaign Period 1 will end 30 November 2020.

For example, if a Razer Pay User becomes verified in July 2020, he/she be eligible to claim one (1) Coupon for each of the months of July, August, September, October, November 2020 only but not December 2020 i.e. subject to a maximum of five (5) Coupons.

- (ii) Razer Pay Users who make a Razer Pay Transaction at Participating Merchants in a single day i.e. Razer Pay Transaction with minimum spend of RM10 in a single transaction, during Campaign Period 2, will receive one (1) Coupon, and limited to one (1) Coupon per day. The coupon can only be redeemed by Verified Razer Pay user.

For example, a Razer Pay User makes four (4) Razer Pay Transactions in a day, he/she will receive only one (1) Coupon.

For example, an unverified Razer Pay User receive the Coupon, he/she will not be able to redeem until his/her account is verified.

Where Razer Pay Users combine other coupons with a Razer Pay Transaction, the amount in respect of the other coupon(s) utilised will not be counted into the minimum spend requirement of RM10 for the Coupon(s) under section 3(a) (ii) of these Campaign Terms.

For example, a Razer Pay User pays for a RM10 item by utilising (a) a RM2 coupon in his/her Razer Pay app and combining it with (b) RM3 from his/her Razer Pay e-wallet, that transaction will not be eligible to receive the Coupon.

4. Limitations of the Coupon(s):

- a. Coupon is valid for one time use only.
- b. Coupon issued during Campaign Period 1 and Campaign Period 2 is valid for up to 30 calendar days from the date the Coupon is issued. Once Coupon has expired, it will be forfeited and become invalid.
- c. You will not be entitled to any refund or credit for any unused/unclaimed/expired/lost/damaged Coupon or Mask.
- d. Coupons are limited in quantity and subject to availability.
- e. Coupons are as stated, non-assignable, non-transferable and non-exchangeable for cash.
- f. Coupon can only be used by verified Razer Pay user.

5. How to collect your Mask:

Razer Pay User(s) can collect your Mask at the nearest participating 7-Eleven outlet (to find the nearest outlet, please visit <https://www.razer.com/campaigns/razerforlife/my/free-masks-for-malaysia>). Allow the cashier at the participating outlet to scan the QR code linked to the Coupon by tapping on Pay.

6. Razer Pay™ Users' Obligations

You acknowledge and agree that:

- a. Your participation in the Campaign constitutes your acceptance of these Campaign Terms;
- b. You are responsible for and shall comply with all Campaign Terms and you shall not, as part of your participation in the Campaign, breach any of these terms;
- c. You shall comply with all applicable laws when participating in the Campaign;
- d. You are responsible for all information that you submit, transmit or otherwise make available during your participation of the Campaign whether to Razer Pay or third parties;
- e. You shall not participate in the Campaign nor permit the participation of the Campaign in any manner which may adversely affect other Razer Pay™ users' participation or the reputation/goodwill of Razer;
- f. Razer Pay to the fullest extent permitted by law excludes all warranties, rights and remedies (including warranties implied by statute or otherwise) that you would otherwise be entitled to by law;
- g. Where Razer Pay deems that you have breached any of the Campaign Terms, including fraudulently participating in the Campaign, it reserves the right to:
 - prevent or restrict access of any user to the Campaign, the Razer Pay™ mobile app, or any of the Razer Sites, platforms/services; and/or
 - report any activity it suspects to be in violation of any applicable law, statute or regulation to the appropriate authorities and to co-operate with such authorities.

7. Masks

- a. You understand and acknowledge that the Masks and Coupons are subject to the availability of resources including, without limitation, Razer Sites and/or the Razer Pay™ mobile app and associated Razer Pay platforms and systems.
- b. You accept that Razer Pay shall not be responsible to You for any loss, damage, fine, regulatory action, claim or compensation of whatever nature arising from or related to the Campaign or Masks ("**Liabilities**") including but not limited to (i) Your breach of these Campaign Terms, (ii) Any alleged unauthorized transactions, disruptions, errors, defects or unavailability of the Masks or Campaign, or (iii) Any loss of data or damage to any mobile equipment of You, to the fullest extent permitted by law.
- c. Razer Pay does not make any warranty or representation whatsoever, express, implied or statutory in relation to the Campaign and the Masks, **Razer Sites**, Razer Pay™ mobile app and/or any software or hardware, or any application accessed by you using the **Razer Sites**, including without limitation, the merchantable quality, fitness for purposes, the performance and capability in respect of the Masks and level of care and skill in respect of the relevant services provided in conjunction with the Campaign.
- d. All visual(s) of the Mask(s) and Campaign shown in any advertisement, Campaign publicity and other materials relating to this Campaign are solely for illustration purposes only and may not depict the actual colour/characteristics of the Mask.
- e. MASKS ARE PROVIDED AS-IS WITH ALL FAULTS, AND RAZER PAY SPECIFICALLY DISCLAIMS ALL WARRANTIES, EXPRESS OR IMPLIED, INCLUDING (WITHOUT LIMITATION) IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE. RAZER PAY SPECIFICALLY DISCLAIMS THAT MASKS WILL PREVENT INFECTION OR THE TRANSMISSION OF VIRUSES OR DISEASES. MASKS ARE NOT A SUBSTITUTE FOR PROFESSIONAL MEDICAL ADVICE, DIAGNOSIS, OR TREATMENT, AND ANY MEDICAL QUESTIONS SHOULD BE DIRECTED TO YOUR HEALTHCARE PROVIDER. THE ENTIRE RISK AS TO THE QUALITY AND PERFORMANCE OF THE MASK IS WITH THE RAZER PAY USER. RAZER PAY ASSUMES NO LIABILITY FOR INACCURACIES OR MISSTATEMENTS BY THIRD-PARTY SELLERS.

8. Miscellaneous

- a. Razer Pay reserves the sole and absolute right to rescind a Coupon or reject/disqualify (whether under these Campaign Terms or where a Razer Pay™ User has engaged in a conduct that Razer Pay considers inappropriate or unacceptable), any Razer Pay™ user deemed ineligible for the Campaign.
- b. Razer Pay reserves the right to limit the usage and application of any of the Coupon issued in connection with the Campaign at any time and from time to time in its sole and absolute discretion.
- c. Razer Pay Users in the Campaign must comply with all up-to-date spam laws.
- d. Any clause in these Campaign Terms, terms and conditions/service of Razer Sites and/or Razer Pay™, Privacy Policy (<https://www.razer.com/legal/razer-pay-sg-privacy-policy>) as well as such other terms and conditions as agreed or accepted by You, that are invalid, unenforceable or illegal shall be enforced as far as possible in accordance with its terms, but shall otherwise be deemed severed and shall not affect the enforceability of any other Clauses, which Clauses shall continue to be valid and enforceable to the fullest extent permitted by law.
- e. Razer Pay reserves the right to alter, modify, add to or otherwise vary these Campaign Terms & Conditions at any time, and in such manner as Razer Pay deems appropriate, without giving any prior notice to You or Razer Pay Users. You shall be bound by the Campaign Terms & Conditions so amended. In any event, if you continue to participate in the Campaign or use the Mask after such notice, you shall be deemed to have accepted the amendments.
- f. Razer Pay shall not be liable for non-performance, error, interruption or delay in the performance of its obligations under this these Campaign Terms & Conditions (or any part thereof) or for any inaccuracy, unreliability or unsuitability of the Campaign or Mask.
- g. By participating in the Campaign, you give your consent to and authorize Razer Pay to collect, use, process, your names, masked Identification Numbers (IC) and other particulars/personal data for the purpose of running the Campaign, including but not limited to announcing and publishing your personal data and/or photos for advertising and publicity purposes.
- h. Razer Pay's decisions on any matter related to the Campaign shall be final and conclusive.
- i. Razer Pay shall not be liable for any claims by Razer Pay™ Users or third-party claims or losses of any nature, including but not limited to, loss of profits, punitive, indirect, special, incidental, or consequential damages or for other damages and any related claims of any nature, including direct, indirect, third-party, consequential or other damages resulting from or in connection with this Campaign howsoever arising whether in contract, tort, negligence or otherwise even if they have been advised on the possibility of such damages in advance, and furthermore all such damages are expressly excluded.
- j. Razer Pay Users shall not participate in the Campaign nor permit the participation of the Campaign in any manner which may adversely affect other Razer Pay Users' participation or the reputation/goodwill of Razer Pay.
- k. This Campaign is in no way sponsored, endorsed or administered by, or associated with Facebook, Twitter, LinkedIn, or any other social network or media.
